Which entity is responsible for issuing the Conveying Contractor license in Alabama?

ANSWER B

WHY In Alabama, conveying-type contractor licenses are administered through the Alabama Licensing Board for General Contractors (often referenced alongside the Alabama Builders Licensure Board). The Department of Labor, Department of Commerce, and the Engineers and Land Surveyors Board do not issue this license.

ANSWER A

WHY The Conveying classification in Alabama covers the installation, service, and repair of conveying systems such as dumbwaiters, elevators, wheelchair lifts, escalators, and similar equipment. Structural steel framing, HVAC systems, and precast concrete manufacturing fall under different classifications and are not included in the conveying scope.

Gross revenue, years in business, or personal subcontractor guarantees are not used as the threshold criteria.

ANSWER B

Friends, family, employees, and unrelated contractors are not acceptable qualifying references.

ANSWER A

WHY Alabama licensed contractors must carry workers' compensation as required by Alabama law and general liability insurance meeting the minimum amounts set by the Licensing Board for General Contractors. Marine cargo and blanket flood insurance are not required license coverages.

NFPA 13 covers sprinklers, ASTM C150 covers cement, and ASHRAE 90.1 covers energy—none of these govern elevator installation.

WHY True. Alabama contractor licenses are issued and renewed under the schedule established by the Licensing Board for General Contractors. Performing work after a license has expired without renewal is grounds for disciplinary action and administrative penalties.
