SINGLE CHOICE

Under Alabama law, which state agency is responsible for licensing and regulating private investigators in the state?

ANSWER B

WHY Private investigators in Alabama are licensed and regulated by the Alabama Private Investigation Board (APIB), which is established under the Alabama Private Investigation Act (Code of Alabama § 34-25B-1 et seq.). The Board sets licensure requirements, promulgates rules, and enforces the standards governing the profession.

ANSWER B

WHY Alabama's Private Investigation Act sets baseline eligibility requirements including minimum age (21) and U.S. citizenship or lawful presence in the country, along with good moral character and other qualifications. A specific degree or federal law enforcement background is not required for a standard private investigator license.

ANSWER B

WHY Licensed private investigators are ethically and, in many circumstances, legally obligated to report credible information about ongoing felonies to law enforcement. Withholding such information to protect a client's interests is not permitted, and investigators must prioritize public safety and legal compliance over client confidentiality in these situations.

Which of the following is a permissible surveillance activity for a licensed Alabama private investigator?

ANSWER C

WHY Overt visual surveillance conducted from a location where the investigator has a legal right to be, such as a public place, is a lawful and standard investigative technique. Trespassing to place a GPS device, intercepting mail, and unauthorized recording of conversations violate state and federal privacy laws.

ANSWER C

This is essential for the evidence to be deemed admissible and credible in court proceedings. Chain of custody applies regardless of the court in which the evidence may be introduced.

WHY Investigators must decline work that would constitute unlawful harassment, stalking, or an unjustified invasion of privacy. Conducting surveillance without a legitimate investigative purpose exposes both the investigator and client to civil and criminal liability and violates the professional and ethical standards of the profession. Passing work to unlicensed individuals also violates licensing laws.

ANSWER C

WHY Federally, the Wiretap Act (18 U.S.C. § 2511) prohibits the interception of oral, wire, or electronic communications without the consent of at least one party, subject to state law variations. Investigators must understand both federal requirements and the specific consent rule of the jurisdiction in which they are operating before recording any telephone conversation. Calling a business, leaving a message, and one-party-consent recording are generally lawful.

Under Alabama Administrative Code, what is the minimum age required for an individual to be eligible to apply for a private investigator license?

ANSWER C

WHY Alabama Administrative Code r. 770-X-1-.04 sets the minimum age for licensure as a private investigator at 21 years. Applicants must also meet other requirements such as being a U.S. citizen, a resident of Alabama, and of good moral character, but the minimum age requirement is 21.
