Under Alaska Statute 08.18, a residential contractor endorsement is required for contractors performing work on what type of structures?

ANSWER A - B

WHY Building a new single-family home and performing major renovations on a duplex both require the Alaska residential contractor endorsement because they involve residential structures within the one to four family unit scope. Commercial work (option C) requires a general contractor license, six-unit construction (option D) exceeds the four-unit threshold, and minor repairs under the dollar threshold may not require the endorsement depending on the scope of work.
