ANSWER A

WHY Most jurisdictions in Arizona require a Notice of Intent to Demolish (or similar demolition permit notification) be filed with the local building or safety authority before wrecking operations begin, which helps coordinate inspections for utilities, asbestos, and adjacent property protections.
