ANSWER A

WHY Max Weber famously defined the state as the entity that successfully claims a monopoly on the legitimate use of physical force within a given territory. The other options describe different concepts (class-based or consent-based theories, or federal arrangements) that do not match Weber's definition.

In the United Kingdom, what is the primary function of the House of Lords?

- ☐ **A** To appoint the Prime Minister after a general election.

ANSWER B

WHY The House of Lords acts as the revising chamber of the UK Parliament, scrutinizing and amending legislation originating in the House of Commons. The Prime Minister is chosen by the elected party in the Commons, the supreme court function is held by the UK Supreme Court, and Cabinet members are appointed by the PM.

QUESTION 3

Which of the following best characterizes the role of the Russian Federation Council?

ANSWER D

WHY The Federation Council is the upper chamber of Russia's bicameral Federal Assembly, with representatives drawn from the country's federal subjects (regions and republics). The lower house is the State Duma, the President is elected directly by citizens, and the Prime Minister heads the government.

In China's political system, what is the relationship between the Chinese Communist Party (CCP) and the state government?

- ☐ A The CCP and the state government are constitutionally separate institutions with equal power.

ANSWER B

WHY China is a one-party state led by the CCP, which holds decisive political authority. Party leaders typically hold concurrent state positions (for example, the CCP General Secretary is usually also President), and Party decisions guide state policy. The NPC is a state organ under Party leadership, not the reverse.

ANSWER C

WHY Mexico's Chamber of Deputies combines 300 single-member district seats elected by first-past-the-post with 200 seats allocated by proportional representation from closed party lists. The President is directly elected by citizens, and since 2000 Mexican voters have regularly elected candidates from multiple parties.

ANSWER C

ANSWER A

WHY Nigeria is divided into 36 states plus the Federal Capital Territory (Abuja). This structure has been in place since 1996, following earlier reorganizations that reduced the number of states from the original three created at independence.

ANSWER B

WHY Political culture refers to the patterned orientations that citizens hold toward political objects—the political system, its institutions, leaders, and one's own role within it. This concept, developed by scholars like Gabriel Almond and Sidney Verba, distinguishes informal attitudes from formal institutions (rules) and policies.

QUESTION 9

MULTIPLE CHOICE

Which of the following are characteristic features of a liberal democracy? (Choose two.)

ANSWER A - B

WHY Liberal democracies are defined by free, fair, and competitive multiparty elections and by constitutionally protected civil liberties. Single-party dominance and state control of media are features of authoritarian regimes, not liberal democracies.
